INCMA WORKING TO PROTECT TITLE V AIR PERMITTING AFFIRMATIVE DEFENSE

EPA published a final rule last July removing a company's use of an "emergency" as an affirmative defense against enforcement actions associated with Title V permits. EPA provided states with an interim period to align state permitting programs. While Indiana is sorting out how quickly they can change our state rules to comply, there are concerns that IDEM enforcement staff are already disregarding foundry permit holder's use of the affirmative defense which will likely spread to all permitted sectors. INCMA has reached out to the IMA and Chamber as well as the Commissioner's office to express our concerns and to request a meeting. FIGHTING EPA'S NEW PM 2.5 STANDARDS

The National Association of Manufacturers (NAM) has launched a sign-on letter to congressional

leadership, calling for action on two
Congressional Review Act resolutions that would disapprove of the EPA's recently finalized PM2.5 standard. This rule undermines industry's ability to invest in local communities and will ensure permitting gridlock for years to come. It will hamstring U.S. economic growth, job creation and competitiveness—and
