## LEGISLATIVE SUMMER STUDY TOPICS

As reported by Sally Rideout/INCMA Lobbying: The State Legislative Council met this week to consider and assign topics to interim study committees. Of the 160 proposed study topics, and half dozen projects proposed, House and Senate leadership chose only 42 topics for review "that had a consensus or majority." Their assignments left eight standing committees with no topics slated for study, including: Natural Resources, and Environmental Affairs. A primary focus is on the

State and Local Tax Review Tax Force that is charged with undertaking a holistic review of the state system. ## AFS FEDERAL ENVIRONMENTAL FOCUS

During an AFS webinar in May, several federal issues were identified as priorities in the coming year including a significant focus on environmental matters including:

- EPA Agenda & Budget
- PM 2.5 NAAQS
- PFAS
- EPA's IRIS Health Assessments, and
- Climate Change A few key points made during the presentation emphasized: 1) 61 new policies under the Biden admin, and 88 Trump admin. policies overturned to date. 2) EPA is proposing to lower the current annual PM 2.5 standard by approximately 20%. EPA is proposing PFAS drinking water standards to below detection. 3) Several chemicals are undergoing new IRIS health assessments which could lead to new regulations. 4) The DOE finalized a rule to phase out incandescent light bulbs by August.
