28, is the most recent and potentially farreaching of the administrations' climate initiatives... Of particular importance for environmental practitioners and the regulated community, the OECA directed, "Enforcement staff should ensure consistent consideration of climate change during the case development process and incorporate relevant climate mitigation considerations in administrative actions, civil referrals, consent decree approval requests, and referrals for criminal prosecution sent to the Department of Justice." This includes anticipating and accounting for future extreme weather events when resolving regulatory enforcement cases by including relief that will be resilient to the projected impacts of climate change. # EPA Finalizes Rule to Require Reporting of PFAS Data

On Sept. 28th, finalized a rule to provide EPA, its partners, and the public

with the largest-ever dataset of per- and polyfluoroalkyl substances (PFAS) manufactured and used in the United States. This rule is deemed to be a kev action in EPA's PFAS Strategic Roadmap. PFAS are a category of manufactured chemicals that have been used in industry and consumer products since the 1940s. **PFAS** have characteristics that make them useful in a variety of products, including nonstick cookware, waterproof clothing, and firefighting foam, as well as in certain manufacturing processes.
